2. Area of Planned Activity

Post-construction inter array cable over trawl surveys are to take place within the confines of the Beatrice Windfarm. The exact directions of the trawl runs will to some extent be determined by weather and tidal conditions at time of survey.

The Beatrice Windfarm is located approximately 11nm SE of Wick. The boundary of which has been outlined in red in Figure 1 below.

(Note – trawls will start and end within the site boundary).

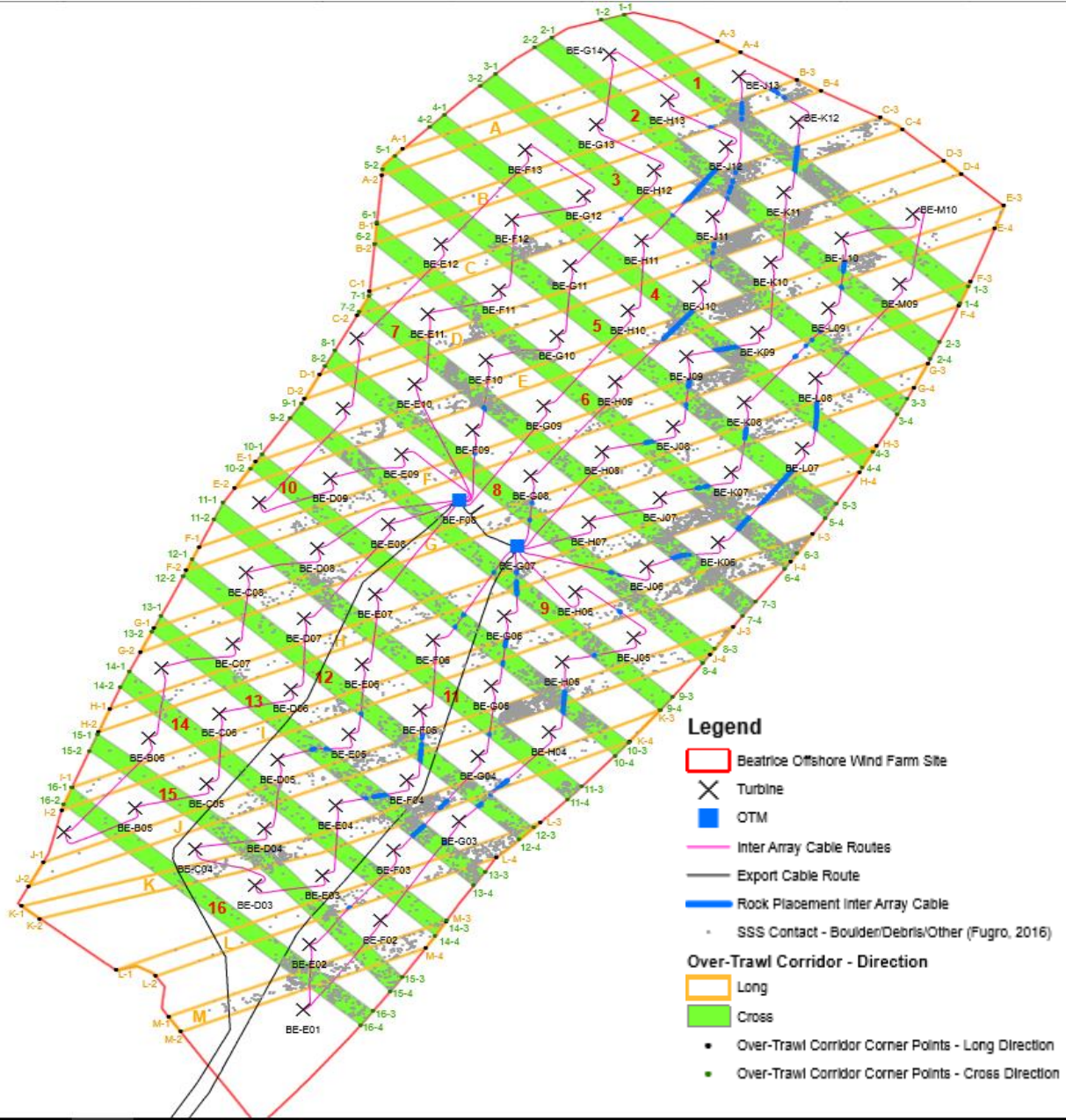

3. Activity Description

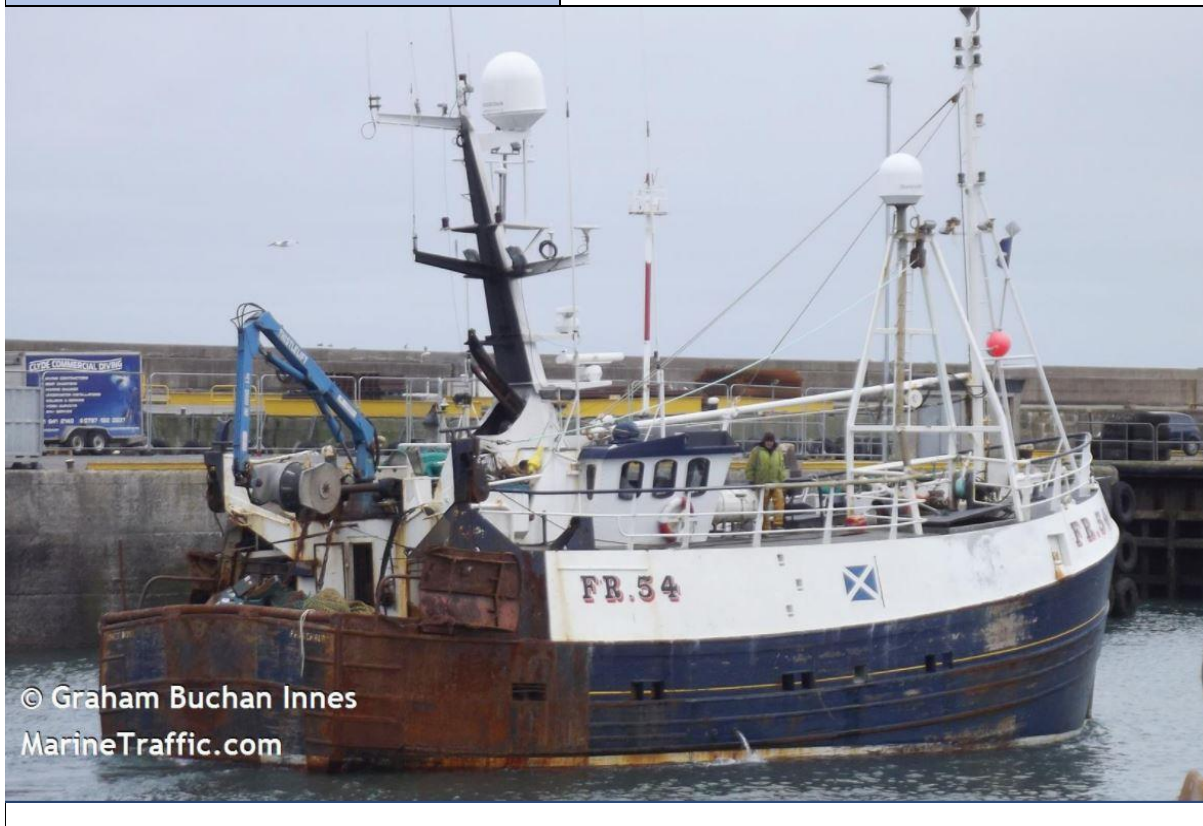
